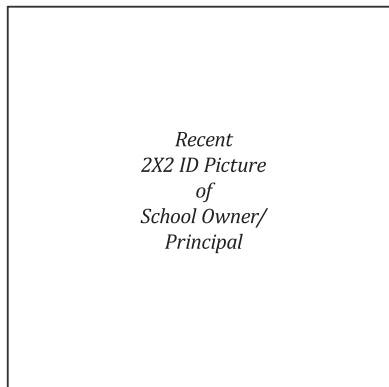

A. Who can qualify as TLC Partner Schools?

All private schools in **Taguig with DepEd Recognition and preferably those with PAASCU Accreditation.** The school must have an **updated Business Permit from Taguig City Government**, and that the applicant-school must have a **demonstrated capability to take in more high school students.**

B. What are the requirements for aspiring TLC Partner School
(Existing Partner Schools also need to accomplish this)

- Filled out application form
- ___ Letter of Intent addressed to the Mayor stating the number of Grade 7 slots that your school can accommodate this coming SY 2023-2024;
 - ___ Copy of DepEd Recognition/DepEd Permit for SY 2023-2024
 - ___ Permit to operate for Senior High School;
 - ___ Securities and Exchange Commission (SEC) Registration/Certification *(for NEW Partner Private School Only)*;
 - ___ Copy of 2023 Business Permit from the City of Taguig;
 - ___ Certified copy of Annual Tuition, Miscellaneous, and other fees collected *(with detailed breakdown of items and amount/Please use the attached format)*;
 - ___ Updated Basic Education Information Sheet (BEIS) SY 2022-2023 – duly signed by signatories every page;
 - ___ Updated School Improvement Plan (SIP); and
 - ___ Latest COLORED photos of school facade, rooms, library, canteen, laboratory and other facilities;
- These documents must be submitted to the **SCHOLARSHIP OFFICE**, 31st cor 51st Sts., Pamayanang Diego Silang, Ususan, Taguig. Applications with incomplete requirements shall not be processed.*
